From the South



Fraternal Greetings from the South,

Freemasonry offers us many lessons, but some of the most enduring come from the simple tools of the trade—tools that have been used for centuries by craftsmen and, symbolically, by Freemasons. This month, as Junior Warden, I'd like to reflect on two of these working tools: the 24-inch gauge and the common gavel. Their symbolism is both deep and timeless, but their practical application is what I find most compelling.

The 24-inch gauge represents time—one of the most precious resources we have. Divided into three equal parts, it teaches us the importance of balance: eight hours for labor, eight for rest, and eight for service to others. In today's fast-paced world, where work and rest often blur, the gauge reminds us of the importance of allocating our time wisely. Whether we are laboring to support our families, resting to renew our minds, or serving our fellow man, the 24-inch gauge calls us to live with purpose and mindfulness.

The common gavel, used by the operative mason to smooth the rough edges of the stone, symbolizes the refinement of our character. It encourages us to chip away at our vices and imperfections, gradually improving ourselves to be worthy of building something greater—whether that's a strong family, a successful career, or a compassionate community. Just as the rough ashlar is made into a perfect stone, we too can improve ourselves daily by using the common gavel to smooth our rough edges.

One Masonic story that embodies the teachings of the gavel is that of Hiram Abiff, the master builder of King Solomon's Temple. Hiram is revered for his unwavering dedication to the craft, his discipline, and his integrity. According to tradition, Hiram refused to reveal the secrets of the Master Mason's word, even under the threat of death, showing that his character was as finely crafted as the stones he worked with.

His story is a reminder that, just like Hiram Abiff, we must stand firm in our principles, refusing to take shortcuts or compromise our moral integrity. The gavel in our hands is not only for the improvement of our own lives, but for ensuring that we contribute to building something larger and more enduring.


These tools offer practical lessons for today's life, reminding us to focus on two key areas: balance and self-improvement. The 24-inch gauge challenges us to reflect on how we spend our time. Are we devoting enough energy to what truly matters? Have we allowed work to dominate at the expense of rest or family time? The gauge asks us to be deliberate and thoughtful in how we allocate our most precious resource. The common gavel, on the other hand, is a tool of self-reflection. It calls us to take stock of our own lives and smooth out the rough edges of our character. Are we harboring habits or attitudes that hinder our progress? Do we treat others as we would want to be treated? The gavel's message is simple but profound: through constant effort, we can become better versions of ourselves, better husbands, better fathers, and better brothers.

As Freemasons, we are taught that the journey of self-improvement is never complete. The 24-inch gauge and the common gavel, though basic tools, offer powerful reminders of how to lead balanced, meaningful, and principled lives. As we go about our days, let us remember the lessons these tools teach and strive to apply them in all aspects of our lives, both within and beyond the lodge.

May we each, like Hiram Abiff, work tirelessly to build not only temples of stone, but temples of character that will stand the test of time.

Training Camp



Everybody knows that officers' coaches are supposed to coach lodge officers. And on occasion they respond to procedural or ritual questions from one of the brothers.

At one time, ritual was learned mouth-to-ear. That means somebody speaks words to you and you memorize them. I remember the first time I took the Junior Steward's part in a third-degree conferral. The officer's coach explained what I was supposed to do. Then he told me what to say. I tried to repeat it back. Then he told me again and again, until I could repeat is back correctly and confidently. Then I was ready to do my part in the degree.

When using a cipher book became legal, we adjusted our technique. We still learn our words

mouth-to-ear. But we learn to use the cipher, so we can remember the words on our own. This change saves a lot of travel time and schedule conflicts.

The requirement is that during degree conferrals and stated meetings, it is illegal (masonically) to use the cipher book. So, you still have to memorize your part. If you get stuck while performing, the prompter will assist you. Our go-to prompter is Wor. Helmuth Litfin, who is also an appointed officers' coach. Were it not for his contributions, I would be much less effective at coaching the officers.

Pretty much all the jobs in the lodge are like that. One brother is elected or appointed to a position. He works with other brothers, be they invited, appointed, or volunteered.

That is teamwork, a skill you can develop in lodge and take it with you to your work, community, faith organization, and any other causes or projects you might take on.

Teamwork means you work with other people. And people, being human beings, will sometimes let you down. They don't return your call. They promise to be there and then don't show up. They say they are ready to work, then you discover that they have no idea what to do.

That is leadership, another skill you can develop in lodge and take with you to your work, community, faith organization, cause, or project.

There is one area of teamwork that I think the brothers of Friendship Lodge could stand to improve. We need to work on being there. Especially for degree conferrals.

When an applicant becomes a candidate, and takes his first degree, he encounters an onslaught of words and actions, things he has neither seen nor heard before. He finds comfort and encouragement when he sees the brother who signed his application sitting on the sideline or participating in the ritual. We say a brother recommends and vouches for him. And there he is, right there at the degree ceremony. And the other members of the lodge he knows. He feels welcomed.

Unfortunately, as I have observed in recent years, signers of applications often do not attend the

degree conferrals of the candidates they recommended. This situation happens throughout Masonry. I have enjoyed welcoming many a brother into the lodge or other Masonic body. But the individual who should be doing that is the brother who signed his application.

Today everybody is busy. And Masons are busier than most. You know you're a true Mason when you have to skip one Masonic activity in order to attend another. Like it or not, prioritizing is difficult. Active Masons often have multiple responsibilities in multiple organizations.

If you good at something, expect to be asked to do more. It's a complement, not a punishment. However due to the low number of members able and willing to participate, those who are left end up taking on more than they can handle. Hence even the most active members sometimes miss an important event.

Masonry is undergoing a lot of changes. We don't have the figures from Grand Lodge yet, but this year, our membership numbers may level off. That means, as many men joined Masonry as those who died or reneged on their membership.

Just as it takes a "It takes a village to raise a child"¹, *It takes a lodge to raise a Mason.* A couple of guys can't do it. A YouTube video cannot do it. There are no do-it-yourself Mason kits. And you can't simply import them from China.

Men read about Masonry and become interested. They go to the Grand Lodge website for information. Or they just walk through the door of their neighborhood Masonic center. They are coming. It is our responsibility to welcome them and guide them to making the decision to become a Mason.

You could do it all if you had the time. We all get the exact same amount of time. And for most of us, there is never enough. We must prioritize. Hopefully after family and employment, we can find a little time for the gentleman who just walked through our door. And help he find what he is seeking.



- 2. Eliminates certification requirements for certain documents under Part 14 of the CMC (regarding masonic trials).
- 3. Suspends a member who fail to plead to charges of un-masonic conduct.

- Updates required applicant contributions and amounts to Masonic Homes, Memorial Temple, George Washington Masonic National Memorial; to be established as part of the 2025– 2026 Grand Lodge budget and adjusted as needed thereafter.
- 5. Lengthens restoration repayment period provided to members suspended for nonpayment of dues, from 2 years to 3. And grace period for members on active military combat duty, from 2 years to 3.
- 6. Modifies the lodge vote required to restore a member who was suspended for non-payment of dues from 2/3 to majority vote.
- 7. Allows for a plain-language text ritual, as opposed to the cipher ritual.
- 8. Clarifies procedures to approve alternate rituals.
- 9. Requires submission of Grand Lodge officer nominations and biographical sketches at least 60 days prior to the Annual Communication.
- 10. Permits the Grand Master to appoint an Assistant Grand Lecturer who is a Past Master or any constituent lodge. AGL no longer required to belong to a lodge in his particular division.
- 11. Permits a Secretary of one lodge to serve as Master, Warden, or Secretary of another lodge.
- 12. Shortens the process required by the CMC for lodge consolidations.

Carry-over Legislation from 2023

This legislation received enough votes last year to qualify for reconsideration this year. Each of these recommendations requires a 2/3 affirmative vote for adoption.

23-01 Permits a lodge to email meeting minutes to members. In which case the minutes would *not* be read at the next Stated Meeting. Members may any report errors or omissions before and during the next Stated Meeting. Requires a standing resolution of the lodge.

23-03 Allows Special Meetings to be held on the same day as Stated Meetings. Allows a lodge to hold a degree conferral, masonic funeral, candidate examination, or installation of officers on the same day as the lodge's Stated Meeting.

23-05 Permits a lodge to appoint a specific Past Master to cast the Past Masters' collective vote at the Grand Lodge Annual Communication.

New Legislation for 2024

There is only one new resolution this year. It requires a 5/6 affirmative vote for adoption. Or a majority affirmative vote to be reconsidered next year.

24-01 Makes the candidate's third-degree proficiency a prerequisite for *nomination* as Junior Warden, Senior Warden, and Master.

Currently, a nominee's third-degree proficiency is a prerequisite for *installation* as Junior Warden, Senior Warden, and Master.
